# 5. Terms of payment

The camp fee is 310€ with a stay duration of 10 days. The camp fee includes full board, program activities, use of infrastructure according to camp regulations and all taxes and fees – for participants bringing their own tents. For unregistered participants catering cannot be guaranteed! Additional services such as transportation and rental objects will be billed separately. The total amount will be split into two partial payments:

- 50 % deposit based on the number of participants as stated in the contract Due: May 30<sup>th</sup>, 2025
- Remaining balance based on actual number of participants and additional services e.g. shuttle service.

Due: September 1st, 2025







Please note that listed prices are special conditions, applicable only to the International Summer Camp 2025 (IFM-SEI). The pricing is only valid for participating groups during the duration of the IFM camp.

The invoice will be issued by Österreichische Kinderfreunde Rote Falken – not through campsite.

#### 6. Cancellation and insurance conditions

Cancellation up to 10% of registered participants is free of charge up to one week before agreed arrival day.

For cancellations of more than 10% of registered participants a cancellation fee must be billed: 25% of the affected contract amount by cancellation within 4 weeks prior the agreed arrival date. Rote Falken Österreich must receive the written cancellation note no later than 4 weeks prior the agreed arrival day of the group.

For registered but not participating groups a cancellation fee must be billed: 75 % of the contract amount by cancellations up to 1 week prior the agreed arrival day. Rote Falken Österreich must receive the written cancellation note no later than 1 week prior the agreed arrival day.

For registered but not participating groups or individual participants a cancellation fee must be paid: 100 % of the contract amount by cancellation within less than a week prior the agreed arrival day.

#### Insurance and health requirements:

The contracting party must ensure that every participant has adequate health, - accident- and liability insurance. In case of illness and needed treatment through a local doctor or hospital the contracting party has to ensure that every participant has a valid Austrian or equivalent foreign health insurance card or another form of verification for a valid and sufficient health insurance for the duration of the planned stay at the Döbriach camp and needs to be shown to local staff upon request. The contracting party is responsible for ensuring that in case of emergency or illness of a participant, medical instructions are followed immediately and completely. The contracting party needs to ensure that every participant has a complete filled out health form which is signed by a legal guardian.

Care and Supervision responsibility: The contracting party or designated people are solely responsible for care and supervision of minor participants. Staff and employees of the camp operator only provide assistance with using camp facilities or organizing leisure activities if needed and requested by the contracting party. The full responsibility for care and supervisions during all activities – especially use of the beach and swimming, creative activities, sports and cultural activities, and the duration of the stay remains entirely with the contracting party.







Child protection: The contracting party is obligated to ensure that all caregivers read and comply the child protection regulations of the IFM-SEI-Camp. With that all caregivers as well as every person above 18 years needs to provide a current youth criminal record extract upon registering for the IFM-SEI-Camp. If there are any issues with receiving a record, please contact us.

**Liability:** The contracting party is liable for any damage to camp facilities, which are caused by improper use and/or negligence in supervision of minor participants or by volunteers, employees, visitors, guests or members visiting the campsite with the knowledge and consent of the contracting party. The camp operator is not liable for damages due to weather conditions or force majeure of the contracting party during its stay at the campsite. The camp operator is not liable for personnel injuries due to minor negligence (§ 1313a ABGB). All liability for property damage is excluded, except in case of intentional harm.

**Compliance of the law:** The contracting party complies with camp regulations, child- and youth welfare laws, child- and youth protection law Carinthia and the camping law as well as ensuring that every (minor) group participant follows the laws and regulations. Said regulations are available for review at the administration office of the camp operator. The camp operator will handle all necessary registrations for events for the planned and included activities. If groups plan additional events that may fall under Austrian/Carinthian event law, the contracting party is fully responsible for the organisation, including necessary registrations and official procedures. Any associated costs must be covered by the contracting party. The use of loudspeakers, music systems or similar equipment for sound amplification is prohibited. Violation may result in expulsion from the campsite. Any penalty or administration fee must be paid by the contracting party.

# 7. Data protection

Your personal data will be processed within handling your registration and participation at the seminar or event.

With providing your contact information for registration you consent and agree to the necessary data usage. Data transfer only occurs within our organization.

If needed, your data can be shared with the IFM-SEI office in Brussels and, if applicable, with funding bodies. Your data will be processed as long as necessary for the seminar- and event administration or if any related inquiries need to be solved.

No automatic decision making, scoring, profiling or any similar activities are taking place.

You have the right to access, rectify or delete your data as well as a right to restrict or object processing and data portability. In case of an alleged inconsistency with the protection of your personal data you have the right to file a complaint with the Austrian Data Protection Authority (www.dsb.gv.at).
